1 Business History

Our agenda is to empower government agencies with robust and scalable technology solutions that drive success. Since 2017 we have been significant partners providing audit and assurance for the Ghana Revenue Authority (GRA) to achieve its revenue mobilisation targets. Our two main divisions specialise in the audit of downstream petroleum products value chain and trade transaction pricing and business process audits at our Tema and Osu offices respectively.

3 What we do

a. Petroleum Sector - We offer

- Real-time monitoring and audit of petroleum products with our cutting-edge software platforms and hardware technologies to enhance security and curtail irregularities in product flow nationwide.
- Digitisation of physical documents used to capture petroleum data lifted at the various depots.
- Data management services in real-time through our secure database.
- Uninterrupted 24-hour remote surveillance via our A.I. risk management system.

b. Port Services - We offer

- External price verification service to the Customs Technical Services Bureau (CTSB) by providing them with a reliable and current pricing database of products in our TVAS system.
- Reassessment services for trade transactions that are classified and valued by Customs to identify discrepancies or errors that may lead to revenue losses.
- All reassessment data is made available to Customs Post Clearance Audit (PCA) department for further action.
- Comprehensive report and recommendations to relevant stakeholders in the industry to enhance transactional accuracy and mitigate financial risks.

4 Benefits from our effort

a. Petroleum Sector:

 Recurring petroleum liabilities have been reduced to the barest minimum due to the introduction of SML Real-time monitoring. Consequently, OMCs liftings are all now reflected in ICUMS for tax purposes.

a. Petroleum Sector:

- SML's intervention has ensured consistent average taxable volumes of petroleum products since its commissioning in June 2020. This has yielded significant additional tax revenue in the downstream petroleum for the government.
- Before SML, data transfer delays for product liftings from ERDMS to ICUMS allowed many OMCs to lift products beyond their limit. This accounted for previously accumulated indebtedness by OMCs. By providing real-time audits SML
- offers up-to-date insight into the activities of all OMCs making it difficult for recalcitrant OMCs to continue product liftings.
- Digitisation of customs release orders and waybills provide GRA comprehensive database for reference and reconciliation.
- 24-hour uninterrupted surveillance to detect any flow of petroleum products has secured depots and curtailed any leakages in the petroleum sector at all depots across the country.

b. Port Services:

As part of its internal processes to determine duties payable at the ports, the Customs Technical Services Bureau (CTSB) conducts Valuation and Classification on all Bills of Entry (BOE) line items. The Tariff and subsequent duties are largely dependent on these activities. Errors, application of the wrong values or misclassification will eventually result in financial loss to the State.

- SML's BOEs reassessment brings to the attention of Customs all observed misclassifications, and application of lower item values and the resulting differences in Free on Board (FOB)
- The Post Clearance Audit (PCA)
- Department of Customs, is also provided with our audit observations to facilitate investigation into BOEs already cleared at ports.
- SML's external pricing database supports Customs to determine the accurate item price during valuation.




SMLs end-to-end solutions role for Audit Assurance
